<u>AGENDA APPROVAL</u>: Jim C./Tammy O. made the motion (and seconded the motion) to approve the agenda with an additional agenda item of discussing whether our Chapter should become a 501c(3) organization. The motion passed.

MINUTES APPROVAL: Jennifer V./Lori W. moved that the minutes of September 2020 be approved via email, the motion passed.

PRESIDENT'S REPORT: Pres Tom D. covered these items

- Thanks to 1st VP Jim C. for running the meetings in the President's absence.
- On 6 Nov the AZ COC meeting will be virtual; Pres Tom will send his slides around to the BOD for review prior to the meeting. The virtual meeting will take place from about 8am to 2pm others may attend if they so desire.
- 23 Oct is the annual National MOAA Business, but Pres Tom has not yet seen/received any info regarding the National Mtg.
- MOAA Regional Workshop (see the President's Notes appended at end of Minutes). Also discussed at the workshop were Chapter Management items (also see the President's notes at end of minutes).

TREASURERS REPORT: Treasurer B. Kellock reported:

- Treasurer Bob K. provided a copy of the month's financial report; he reported that the Total Unencumbered Net Worth of the Chapter was \$61,422.72. There was only a \$100 change from last month.
- Treasurer's report is attached to the minutes.
- Tammy O./Jim C. moved that the Treasurer's report be accepted, subject to audit; the motion passed.

SECRETARY'S REPORT: Secretary J. Puett reported:

• No Report.

OLD BUSINESS: Pres Tom D led this discussion

• Pres Tom discussed whether to hold a November Dinner meeting. Since PDS still cannot host our meetings, Susan A-D./Jennifer V. made the motion to cancel our November Dinner meeting, the motion passed.

- Pres Tom and 1st VP Jim C. reported on their efforts to locate a new, more suitable financial institution to host our finances. Jim C. is awaiting some info from Wells Fargo before approaching a new banking institution.
- Pres Tom continued the previous month's discussion on New Board officer nominations (Public Relations & Membership) and elections. As previously discussed, the JROTC & Transition/ESGR incumbents have agreed to an additional term (until Jan '23) and the new Treasurer (Bob K.) has agreed to a full term as well (until Jan '23). Bob C. says he has not received any new nominations for the vacant positions. At the next month the BOD we will decide if the vote for these positions will have to be conducted virtually via email.

<u>NEW BUSINESS</u>: Pres Tom D. led the discussion on these items:

- Pres Tom swore in the new Treasurer, Bob Kellock.
- Pres Tom discussed his outreach to Elgin Elementary School regarding their annual Veteran's Day program (last year the Board approved that the Chapter will provide a \$100 annual contribution to their Veteran's Day program). Tom D. has placed calls but has not yet received any information from Elgin Elementary; it doesn't look like there will be a program, but if there is, Tom D will get with Bob K. to get the \$100 check if needed.
- Pres Tom led a discussion as to whether our Chapter should become a 501c(3) organization (in addition to being a 501c(19) org). There are two advantages to obtaining c(3) status: a) our members can then legally claim tax deductions for their donations to the scholarship fund, and b) community grants appear to be being awarded only to 501c(3) chapters. 1st VP Jim C. will get a formal definition of "War Veterans" for 501c(19). Our donations are currently not tax deductible because 90% of our members are not war veterans (given the number of SS we have in our Chapter), also our Community Grant applications was not approved this year. Tamara O./Jennifer V. motioned for us to become a 501c(3), after discussion; we agreed to table the vote on this motion until next month so that more research can be done. Pres Tom D. will talk with other Chapters that are both c(3)'s and c(19)'s to find out how they are doing this and what the admin burden is of being both types of organizations.

SCHOLARSHIP: Dir S. Atchison-Day reported:

- The 2020-2021 Scholarship Program is underway. The SV Herald will be publishing an article perhaps today. Announcements and Applications were sent to thirteen high schools, with additional letters being sent to the JROTC contact persons at Buena HS and Tombstone HS.
- Susan A-D wants to thank Ron Pflipsen for his past help with the Scholarship Committee. Because of health reasons, he has declined participating this year. Pres Tom D. will send Ron P. a letter of thanks and a MOAA Coin. To replace Ron, Susan is happy to report that Lori Wysong has agreed to join the Scholarship Committee. With her background with the JROTC, she will be an asset.
- All scholarship applications should be postmarked no later than March 1, 2021 and received by Susan A-D no later than noon on March 6, 2021. A room has been reserved at the American Southwest Credit Union again for interviews on March 12 and 19. The Scholarship Awards dinner will be at the April Meeting. Because of the COVID situation, there will be no scholarship nights. All are urged to get application for the qualifying graduating seniors in their lives, neighborhoods and community organizations.
- A question has been raised about who is and is not eligible to apply for a scholarship. Do we want to increase potential applications to children of "all" Veterans instead of just Retired and Currently Serving Veterans? After discussion, we agreed to leave this "as is" (i.e. Retired & Currently Serving).

- Susan A-D needs more BOD member bios (see previous minutes for details).
- Last year, after 20 years on the FBI's most wanted list, Jamel Ahmed Mohammad Ali Al-Badawi, planner of the USS Cole Attack, was killed by an air strike in Yemen. Monday of this week, October 12, marked the 20th Anniversary of the USS Cole Terrorist Attack, in which 17 sailors were killed and another 39 injured. We all remember hearing about and seeing the Navy's Guided Missile Destroyer. It had pulled into the port of Aden in Yemen for fuel and to have waste carried away. After two small boats carried away the waste, a third boat, that

looked pretty much like the first, approached the USS Cole, and we know the rest of the story. This was the first time that Susan A-D remembers Al-Qaeda being mentioned, and we know that just a year later, on September 11, 2001, the twin towers we brought down. It took a few years, but al-Badawi, planner of the USS Cole Attack was tracked down and killed.
