Veterans Day 2024. What is it all about?

The Treaty of Versailles was signed on June 28, 1919, marking the official end of World War I. Nonetheless, the armistice date of November 11, 1918, remained in the public imagination as the date that marked the end of the conflict.

One year later, in November 1919, U.S. President Woodrow Wilson proclaimed November 11 as the first commemoration of Armistice Day. The day’s observation included parades and public gatherings, as well as a brief pause in business and school activities at 11 a.m.



On November 11, 1921, an unidentified American soldier killed in the war was buried at Arlington National Cemetery near Washington, D.C.

On June 4, 1926, Congress passed a resolution that the “recurring anniversary of November 11, 1918 should be commemorated with thanksgiving and prayer and exercises designed to perpetuate peace through good will and mutual understanding between nations.” By that time, 27 state legislatures had made November 11 a legal holiday. An act approved May 13, 1938 made November 11 a legal Federal holiday, “dedicated to the cause of world peace and to be hereafter celebrated and known as ‘Armistice Day.’”

In 1954, after lobbying efforts by veterans’ service organizations, the 83rd U.S. Congress amended the 1938 act that had made Armistice Day a holiday, striking the word “Armistice” in favor of “Veterans.” From then on, November 11 became a day to honor American veterans of all wars.

The observation of Veterans Day was set as the fourth Monday in October. The first Veterans Day under the new law was Monday, October 25, 1971; confusion ensued, as many states disapproved of this change, and continued to observe the holiday on its original date. In 1975, after it became evident that the actual date of Veterans Day carried historical and patriotic significance to many Americans, President Gerald Ford signed a new law returning the observation of Veterans Day to November 11th beginning in 1978.

Veterans Day is not to be confused with Memorial Day—a common misunderstanding, according to the U.S. Department of Veterans Affairs. Memorial Day (the fourth Monday in May) honors American service members who died in service to their country or as a result of injuries incurred during battle, while Veterans Day pays tribute to all American veterans—living or dead—but especially gives thanks to living veterans who served their country honorably during war or peacetime.

A group of friends of the Coronado Chapter gathered together for celebration and remembrance on the 11th of November. We were able to share fellowship through food, laughter, memories, and thanksgiving for the sacrifices made by all veterans, in the pursuit of peace and stability.

We hope you enjoyed the pictures of the First Annual Veterans Day Picnic. Thank you to Allen Goodman and Kathy Youngblood for spearheading this event. We look forward to seeing YOU at next year's event!

I sincerely hope that you are all having a good experience with our Autumn weather and colors. And I also hope that there are no scars or bruises left after this recent election cycle. Special

Thank You goes out to Representative Gail Griffin and to Theresa Walsh. Their drive and desire to serve are extraordinary models of a MOAA member's personalization of "Never Stop Serving."

All of our chapter member's hard work for the candidate, issue, or organization that you supported is important to our community. Without people like you standing up for what you believe is right and logical, we could devolve into 346+million individual person-states with perceived absolute veto rights over others. Your leadership through voting, speaking, or writing on issues helps our community and our leaders to focus.

I write this in hopes that it helps members acquire a better understanding of the "Why and How" MOAA picks topics that the association is going to commit resources to. Much of the information is derived from a recent meeting of Arizona's Council of Chapters. At this meeting we were briefed on how we get where we are going for the 119th Congress and beyond. If you have any need for clarification, questions, comments or recommendations, ask me (j2k2c4@gmail.com).

In short, MOAA will continue to face veteran advocacy challenges ahead. MOAA must maintain key advocacy positions and mission focus on key earned benefits in health care and compensation. These two items are particularly and continually under budget pressure and non-mission centric distractions.

So MOAA National is focused on performance...How can the Coronado Chapter help? That begs the question, "What value does the Chapter System have in supporting MOAA's priorities?"

First, we understand that the following activities fall within the authorized purposes of a Sec. 501(c)(19) organization (Coronado Chapter of MOAA):

- Reviewing proposed legislation that may affect veterans at both the federal and state level.
- Testifying before a governmental body with respect to such legislation.
- Informing members about proposed legislation.

Thus, the greatest values we bring are the underpinning of grassroots advocacy support. Chapters often are the leads in advocacy successes for MOAA. Chapter members are the most successful at performing impactful community engagement activities.

Chapters serve local community needs on a hands-on basis. We (YOU) are key to amplifying the voices of over 360,000 MOAA members.

Next question that our Association is focused on is, "How do we ensure that we don't find ourselves in a situation where everything is important and nothing gets done?" MOAA considers the following criteria when evaluating advocacy targets and priorities.

- Does it fit with the MOAA Mission?
- Do we have the expertise to understand, express, and follow-through?
- Is there momentum among partners and other advocates?
- Is there sufficient and focused MOAA Member interest?
- What are the estimated implementation and maintenance costs?

After considering those elements, MOAA's Government Relations experts have grouped the level and type of attention needed into two groups. Enduring Priorities and Redline Issues. Enduring Priorities are issues we will always advocate for, until passed, even if they are not among our day-to-day priorities, such as concurrent receipt for combat wounded, Arlington National Cemetery access, COLA and restoring BAH to 100%. Redline Issues are those issues that we continually monitor and will immediately mobilize the entire association, our membership, the MSO/VSO community, and our allies to protect. These include reductions to scheduled pay increases as defined by law, any new TRICARE or TRICARE Pharmacy Program fee, TRICARE cost sharing increases that exceed military retired pay COLA or TRICARE Pharmacy Program cost sharing that exceeds common industry practice, and unequal reductions of compensation and benefits based on rank, age, family composition, retirement status, or disability benefits.

So, what action should you be prepared for before and during the 119th Congress session? During this session (January 3, 2025 through January 3, 2027) MOAA has designated the following tiered priorities.

Tier 1 Priorities. From which MOAA will develop and coordinate action teams to take on: Produce engagement plans, actively advocate, develop communication and marketing plans, provide quotes, produce one-pagers, create and promote calls-to-action (CTAs).

- Re: Currently Serving: Unaccompanied Housing Improvements
- Re: Retirees/Veterans: Ending the Wait Report Priorities
- Re: Family/Survivors: Military Spouse Hiring Act
- Re: DoD Health Care: MHS Stability Through Accountability
- Re: VA Health Care: Caregiving Support Improvements

Tier 2 Priorities. These are secondary priorities that MOAA is actively pursuing and working. For example, action teams may take: Provide periodic coverage, possibly produce one-pager and CTAs, and provide quotes, coordinate with Communications Department for news coverage/articles as appropriate.

- Re: Dislocation Allowance
- Re: 180-Day Rule

- Re: Child and Youth Programs (CYP) Improvement
- Re: Federal Employment of Military Spouses
- Re: Parity on FSAs and parental leave for NOAA, USPHS, Coast Guard Reserve
- Re: CHAMPVA Children's Care Protection Act
- Re: Restore Retail Pharmacy Network
- Re: TRICARE Parity Issues (TRICARE Young Adult, Coverage Gap)
- Re: Veteran Caregiver RRR Act
- Re: Women Veterans Care Improvements (SAVE Act)

Tier 3 Priorities are issues we are not actively pursuing or working, with no formal messaging. The actions that the MOAA advocacy team may take include: Sign letters of support, coordinate with Communications Department for news coverage/articles as appropriate.

- Re: Base Pay
- Re: Pay Our Troops Act
- Re: DIC Increase
- Re: Food Security
- Re: EFMP
- Re: Gold Star Definition
- Re: Special Needs Issues Including TRICARE Autism Care Demonstration
- Re: Mental Health Care Access and Copays
- Re: Access to Care
- Re: Dental
- Re: CHAMPVA
- Re: VHA Staffing

I hope that the above gives you adequate information to encourage you to continue what you are doing to support our advocacy efforts. I also hope that it encourages those in our membership who have been holding back.

If the above info doesn't do the trick to get your advocacy juices flowing, Try This. A recent report from MOAA's Legislative Action Center (found at <https://moaa.quorum.us/>) for the period January through October of 2024 provides the following data sheet.

The numbers can be clarified as follows:

- ◆ MOAA (as a whole) records that 5% of all membership has registered on Quorum.
- ◆ With over 300 chapters of MOAA, 17% of those members of chapters are registered on Quorum.
- ◆ Arizona has 9.5% of all Arizona resident MOAA members registered.
- ◆ Arizona MOAA Chapters (ten) see 40% of our chapter membership registered.

AND

Coronado Chapter membership hovered around 260 through this period. Only 11% of our membership is registered on Quorum. Yet almost half of all actions taken in Arizona, in support of MOAA Legislative Advocacy, were made by 51 Coronado Chapter members! What a great thing! I am absolutely sure that this is impactful to Sinema, Kelly, and Ciscomani’s activity plans. Well Done!
