Experienced surviving spouses encourage us all to understand that a key to preparation for, and reducing the stress of our spouses death, is the mantra, "Trust but Verify."

That translates to your responsibility to make sure your spouses (and your) documents express accurate and current situations. Are you named as beneficiary? Are you authorized as an account administrator? Are you listed as a joint owner? Do you know that you have important documents (originals or copies) in your files? Trust that this is done by your spouse, and verify it before they pass on. This will help when you are in the position of making calls, completing forms, and mailing off volumes of information. Those preparations will ease your transition time by reducing your frustrations.

This handbook is designed for use as you face the seemingly daunting task of informing appropriate agencies of the death of your loved one who had served in the United States military services. You must take charge of this workload to ensure that the deceased receives all honors that were earned. You must take charge to ensure that you are fully recognized for the service you provided to the deceased and the nation. You must take charge to ensure that you receive the benefits that you are entitled to.

This handbook can be used as a go-by for you in your walk through the loss. It can be used by a family member or close friend who can read, interpret, and assist when your head is too muddled to do it yourself. It can also be used to start (and record the results of) preparatory discussions between you and your spouse. It is your document.

Collecting Veteran Documents and Discharge Documents

To assist you in the process of receiving benefits for which you may be entitled, you are going to need the following paperwork when communicating with the Veterans Administration office:

PREPARATION

- Discharge papers (DD214 member-4 or equivalent)
- Veteran's death certificate (copy)
- Proof of your relationship to Veteran (marriage certificate, birth certificates)

Where can I find a Veteran's separation documents if I don't have them?

To find Veteran separation documents or other separation documents of your loved one, visit https://www.va.gov/records/get-military-service-records. Surviving family members should make duplicate copies of all documents and retain them for their personal files before mailing them to a processing center.

Notifying Important Parties

	Inform Express Scripts to stop the recurring prescriptions, for which you will continue to pay co-pays on. You must be 'authorized' to access the veteran's Express Scripts account in order to cancel the prescriptions.
	Any fraternal group that you have membership with: e.g., MOAA, FRA, NCOA, VFW, AL, TREA
	Any previous employers that provide pension or benefits.

Coordinating Funeral Arrangements and Burial

First, decide and arrange for memorial/funeral services. Below are the numbers for local and national cemeteries and local funeral homes.

If you or your family have chosen Southern Arizona Veterans Memorial Cemetery for interment, they will require the veteran's DD214 (military discharge papers - all branches of service use the same form) and marriage certificate; also note that SOUTHERN ARIZONA

veteran spouses are eligible for burial here at the cost of \$780.

There are many more local Cochise County funeral homes that will help with your needs.

Burial benefits available include a gravesite in any of the VA national cemeteries or state veteran cemeteries with available space, opening and closing of the grave, perpetual care, a government headstone, marker, or medallion, a burial flag, and a Presidential Memorial Certificate at no cost to the family. Some Veterans may also be eligible for burial allowances. Cremated remains are buried or inurned in national and state cemeteries in the same manner and with the same honors as casketed remains

- To get a burial flag, fill out the Application for United States Flag for Burial Purposes (VA Form 27-2008). Bring the application to any US post office, funeral director, or VA regional office.
- To get a presidential Memorial Certificate (a gold-embossed paper certificate that honors the memory of a deceased veteran and recognizes their service in the United States Armed Forces), you may apply online at va.gov or fill out (VA Form 40-0247) and mail it to the Evidence intake center; the address is listed below.

If the veteran is not interred in a VA or National Cemetery:

- For a headstone, grave marker, or wall marker, fill out the Claim for Standard Government Headstone or Marker (VA Form 40-1330).
- For a commemorative plaque or urn, fill out the Claim for Commemorative Urn or Plaque for Veterans' Cremains Not Interred (VA Form 40-1330UP).

Applying for Survivors Benefits from The Department of Veterans Affairs

As a surviving spouse of a veteran, you may be eligible for several types of benefits, including:

Benefit Type	
Survivor's Pension	A needs-based benefit for low-income surviving spouses of wartime veterans.
Dependency and Indemnity Compensation (DIC)	A tax-free benefit for surviving spouses of service members who died in the line of duty or from a service-related injury or illness.
Health Care Benefits	Access to VA health care services, including eligibility for CHAMPVA (Civilian Health and Medical Program of the Department of Veterans Affairs) if not eligible for TRICARE.
Educational Benefits	The Fry Scholarship provides education benefits for spouses and children of service members who died in the line of duty. • Dependent's Educational Assistance Program (VA Form 22-5490)
Home Loan Benefits	Eligibility for VA home loan benefits to help purchase, build, or refinance a home.

Q&A

How would a spouse or dependents know if they are eligible for VA survivor benefits?

Surviving family members can access detailed information to determine if they are eligible for survivor benefits that may be available by:

APPLICATION PROCESS

- Apply by submitting all required documents, to include the applicable VA Form and the Veteran's death certificate, to the required servicing location (see next page for more information) in one of these ways:
 - Mail to the appropriate VA office that serves your state. You can find the VA mailing addresses at https://www.benefits.va.gov/compensation/mailingaddresses.asp
 - Work with an accredited representative (Veterans Service Organization (VSO) representative, attorney, or claims agent). You can find an accredited

• Go directly to your VA Regional Office for assistance. You can find your local regional office at https://www.va.gov/find-locations

- If approved, take steps to access your awarded benefits

Explore Additional Benefits

Other benefits to check your eligibility and apply for:

Death gratuity	A one-time, nontaxable payment to help designated surviving family members deal with the financial hardships that accompany the loss of a service member.
Unpaid pay and allowances	Upon the death of an active-duty service member, any pay and allowances due, but not paid to the member, are disbursed to the designated beneficiary named on the member's DD Form 93, Record of Emergency Data.
SGLI	Servicemembers' Group Life Insurance is insurance paid to the beneficiaries designated by the deceased service member.
TSGLI	Servicemembers' Group Life Insurance Traumatic Injury Protection is financial assistance for service members who incur qualifying physical losses due to traumatic injuries. This only applies if the service member lived for at least seven days following the fatal incident.
FSGLI	Family Servicemembers' Group Life Insurance is coverage for a service member's spouse and dependent children. For an active-duty death, this normally only applies if the spouse is also a service member.
Thrift Savings Plan	TSP is a retirement savings plan for members of the military that provides two savings options: the traditional TSP and the Roth TSP.
Social Security survivors benefits	Monthly benefits paid to eligible family members of a deceased service member who has worked and paid Social Security taxes.
SBP	The Survivor Benefit Plan is a taxable annuity for eligible survivors paid through the Defense Finance and Accounting Service.
DIC	Dependency and Indemnity Compensation is a tax-free monthly payment to eligible survivors provided by the Department of Veterans Affairs.
HEART Act	The Heroes Earnings Assistance and Relief Tax Act provides tax benefits to surviving family members and disabled service members who received the death gratuity and/or SGLI payments.

Access Counseling and Support

SERVICES

- VA Bereavement Counseling is available at Vet Centers and VA Medical Center Clergy Services. Visit www.va.gov/find-locations to find the center nearest to you. - Educational and Personalized Career Planning and Guidance. Apply through VA Form 28-8832.
- Beneficiary Financial Counseling Service. (https://benefits.va.gov/insurance/bfcs.asp) Beneficiaries can receive services for two years from date of payment at no charge.
- Military OneSource: non-medical counseling and financial counseling for spouses and dependent children
- Tragedy Assistance Program for Survivors: peer mentorship, financial counseling and other resources
- TRICARE: bereavement counseling, medical counseling, family counseling and other support, if TRICARE eligible
